

# 2017 Grant Park Candlelight Tour of Homes



## ARTISTS' MARKET

**Hours of the Market:** Saturday, December 9<sup>th</sup>, 4-9 pm  
Sunday, December 10<sup>th</sup>, 6-8 pm

Thank you for your interest to participate in the Artists' Market for this year's Candlelight Tour of Homes. A well-publicized and popular event each year, the Artists' Market provides a special added feature helping to make this Tour of Homes unique.

We are pleased to showcase the talents of local artists in the sanctuary of St. Paul United Methodist Church, whose stained glass windows are a work of art in themselves. All proceeds from the Artists' Market, like those of the Tour, will be divided among St. Paul United Methodist Church, the Grant Park Parents Network, and the Grant Park Cooperative Preschool.

In 2016, the weekend activities attracted more than 1,500 visitors. The Tour Committee anticipates a similar number to attend this year.

With the success of expanding the market last year, we will keep the number of participating artists to no more than 16. We believe this number of participants will allow for better sales for each vendor and provides enough variety for the Market to continue to be a delightful and popular feature of the Tour.

## COST

Booth Fees will be based on the size of space you would like to have. The cost will range from \$70 to \$140. A map of the space will be sent out to all interested participants by November 3<sup>rd</sup> so that you can determine which space you would like. Spaces will be assigned on a first come, first served basis. We will ask you for a 2nd and 3rd space choice in case your 1st choice is already taken. We can provide you with one standard 6' table and two folding chairs by request. All tables need to be covered with materials/fabric supplied by the artist. Due to the power supply on site we ask that you limit the amount of lighting that you bring to highlight your products. You will be able to plug in (2) two fixtures. We will furnish power strips and extension cords.

## SET-UP & STRIKE

Set-up will be Saturday morning from 10:00 until 2:00 pm, and you will be allowed to re-enter the sanctuary at 3:45 pm. The Artists' Market hours will be 4pm to 9 pm Saturday to coincide with Santa's visitation times. On Sunday the market will open at 6 pm immediately following a Candlelight Christmas Concert in the sanctuary. To be respectful of the musicians and the audience in attendance it is important that we do not open the market until 6 pm on Sunday with an end time of 8 pm (this is usually the busiest time for the market). You are welcome to remain open until 9 pm, but the building will be locked at the close of the tour each night at 10 pm.

## SECURITY

You will be responsible for the sale and security of your products. It is your decision whether or not to leave your merchandise in the sanctuary overnight. The Tour Committee and St. Paul United Methodist Church cannot warrant the security of the building. It is a public building with general access by many people with keys. However, the sanctuary is locked each evening.
